Product Description

IQF mangos are processed from properly ripened mangos, which are washed, peeled, deseeded, and cut into chunks. The product is then individually frozen, packaged and stored.

Food Safety Requirements

The product is prepared under strict sanitary conditions in accordance with Good Manufacturing Practices (GMP) and FSMA regulations, including compliance with EPA pesticide residue and cold-chain transportation. No additives were used in production, and final product should be free from allergens and GMOs.

Physical Properties

Color Yellow to yellow-orange, typical for properly ripened mango. No more than 10% by weight may possess discoloration.

Size 3/4" to 1" (20mm -25mm) with up to 20% units outside range.

Defects Practically free from defects with the following tolerances per pound: 10% mechanical damage, up to 10% clumps (three pieces or less).

Character Units have a tender texture, characteristic of mature, well-ripened mango, which after defrosting retains good conformation and reasonably texture uniformity. By weight, no more than 10% amorphous units.

Flavor & Odor Typical of ripe processed mango and free of any undesirable odor or flavor.
